**Pricing- Please Note: Winter Storage is subject to Ohio sales tax**

**Outside Storage** (Includes Haul-out, Launch and pressure wash of the bottom, provided it is painted\*) ..... **\$19.50 per linear foot**  
There is an additional charge of \$50.00 for the storage season, if the Owner does not provide his/her own jack stands.

**Inside Cold Storage** (Includes Haul-out, Launch and pressure wash of the bottom, provided it is painted\*) ..... **\$3.50 per square foot**  
There is an additional charge of \$50.00 for the storage season, if the Owner does not provide his/her own jack stands.

**Inside Heated Storage\*\*** (Includes Haul-out, Launch and pressure wash of the bottom, provided it is painted\*):  
Boats up to and including 44' in length (LOA) ..... **\$7.00 per square foot**  
Boats 45' and over in length (LOA) ..... **\$7.25 per square foot**

\* **Craft Marine is not responsible for loose striping or bottom paint.**

\*\* **No charge for jack stands in heated storage.** And with his/her Boat in heated inside storage, the Owner may store one (1) personal watercraft ("PWC") on a single trailer or two (2) PWCs on a tandem trailer at an additional charge of One Hundred Dollars (\$100.00) per PWC, provided the total length of the PWC(s) and the trailer does not exceed thirteen feet (13'). The PWC(s) may be placed in Inside Cold Storage at Craft Marine's discretion. The PWC(s) must be titled in the name of the record Owner of the Boat in heated storage; and the Owner agrees to provide proof of ownership on request. If the Boat has a lift system instead of a standard swim platform, the length of the lift system must be included in the length of the Boat for calculating the applicable winter storage charge.

**Boat pick-up & delivery arrangements must be made with Craft Marine Services in advance. Charges for this service, if available, will vary depending on where the Boat is docked. If the Boat does not start at its dock in the Fall, there will be an additional labor charge to get the Boat running.**

1. Craft Marine, Inc. ("Craft Marine") will remove the Boat from the water on the requested haul-out date, or as soon as possible thereafter; and will provide storage for the Boat at Craft Marine Services' storage facility at 400 Broadway Street, Sandusky, Ohio (the "Facility") until May 15th of the following calendar year; provided, however, that if the Boat is stored inside, once weather permits and the Spring launch season has begun, it may be necessary to remove the Boat from inside the Facility and block it outside until it is scheduled for launch to accommodate other boats scheduled for earlier launch. Unless prior arrangements are made with Craft Marine, the haul-out date shall not be later than November 15th. If the Boat or any personal property, including any cradle for the Boat, remains at the Facility beyond June 1st without the prior written approval of Craft Marine and Craft Marine Services, the Owner will incur additional storage charges at the prevailing summer rate for any month or partial month the Boat or such personal property remains at the Facility beyond June 1st.

2. The Boat will not be launched until all storage (including any additional storage charges incurred for storage beyond June 1st), repair and other charges are paid in full to Craft Marine Services and/or Craft Marine, as applicable.

3. The Owner must furnish Craft Marine a set of keys to the Boat for purposes of haul-out and launch.

4. Craft Marine and Craft Marine Services shall not be responsible for nor have any liability whatsoever for any loss, damage, personal injury or loss of life or property within the control of the Craft Marine and/or Craft Marine Services, or their respective employees, agents and/or independent contractors in connection with:

- (a) the Facility premises or the use of the storage space,
- (b) the Owner's vessel, motor, cradle, or accessories, including dock box, fenders, lines, tools, and associated equipment; or
- (c) any loss due to fire, theft, vandalism, collision, Facility equipment failure, windstorm, rain, tornado, or any other casualty loss or act of God or terrorism. **The Owner agrees to cover all the aforesaid risks by appropriate insurance on the Boat and related personal property without subrogation against Craft Marine and/or Craft Marine Services. The Owner agrees to provide Craft Marine Services a current certificate evidencing such insurance.**

5. No person other than the Owner shall work on the Boat at the Facility without the prior written approval of Craft Marine Services; and all such work must be performed Monday through Friday during the regular business hours of Craft Marine and at the full risk and responsibility of the Owner. All persons employed by the Owner must have proper insurance forms on file with Craft Marine Services in order to work on the Boat at the Facility, including but not limited to a certificate of general liability insurance in amounts established by Craft Marine Services and proof of workers compensation insurance coverage. Craft Marine Services, in its sole discretion, may establish a reasonable per diem or other contractor fee payable in advance by outside contractors for the use of the Facility and its water and electricity. No work will be permitted in the Facility that creates a nuisance or other undesirable condition as determined in the sole discretion of Craft Marine Services. Any clean-up or abatement required as a result of unauthorized work or unreasonable mess will be assessed as an additional storage charge at Craft Marine's then-current hourly rate for labor plus materials payable before the Boat is removed from storage.

6. In an emergency, Craft Marine and/or Craft Marine Services have the right to move the Boat to any other available location at the Facility, whether inside or outside the storage building(s).

7. The Owner, his/her agents, employees and guests must comply with all rules and regulations established by Craft Marine Services, a copy of which is attached; and may not engage in any activities at the Facility which create a nuisance or are in violation of any city, county, state or federal law, rule, regulation or ordinance.

8. If the Boat has no bottom paint, an additional charge will be assessed by Craft Marine at its then-current hourly rate for labor for bottom scrub.

9. The location of the Boat in the Facility will be at the discretion of Craft Marine and Craft Marine Services; and Craft Marine and/or Craft Marine Services have the right to move the Boat from time to time as deemed necessary during its period of storage at the Facility. Once placed in storage, the Boat must remain in the Facility for the storage season unless prior arrangements are made with Craft Marine. Electric and water hookups inside and/or outside the Facility will not necessarily be available to the Owner or anyone authorized to perform work on the Boat while it is in storage or may only be available at an extra charge payable in advance.

10. This agreement must be signed by the Owner and returned, together with a Five Hundred Dollar (\$500.00) deposit, to: Craft Marine, Inc., P.O. Box 1488, Sandusky, Ohio 44870. Storage space for the Boat will not be reserved until the signed agreement and deposit are received and accepted by Craft Marine. A total fifty percent (50%) deposit is required by August 15, 2020, and storage space for the Boat will not be guaranteed unless the required 50% deposit is received. The balance of the winter storage charge is due on or before January 15, 2021. If your account is not paid in full when due, it will incur a late charge of 1.5% per month.
